

# Teton Action Rental, LLC. RELEASE AND WAIVER OF LIABILITY AGREEMENT/RENTAL CONTRACT

The lessee agrees to rent the vehicles and other equipment hereinafter referred to as Rental(s), described on numbered invoice at the rates established by the Lessor And to furnish the required deposits to the Lessor, which will be refunded upon the return of each Rental(s) in satisfactory condition. The lessee further agrees to pay for any and all damages caused by his/her negligence while in Lessee's possession and if the Lessee allows another party to use the Rental(s) during the time frame of this agreement. The lessee agrees to return the Rental to Teton Action Rental on or before the day and time indicated unless other arrangements have been made by mutual agreement of Lessor and Lessee. Lessees agree to keep each Rental(s) in a safe place while unattended. Operating any Teton Action Rental, LLC Rental(s) while under the influence of alcohol or drugs is strictly prohibited and will void the rental contract and collision protection plan. *Rental term may be suspended at any time if deemed necessary by Teton Action Rental or any law enforcement agency.*

1. Security deposit \$500 per machine, credit card only. **Must have credit card # on file**
2. Rental prices are Per Day. Seven days cancellation notice required for refunds. Deposit is non-refundable if cancellation occurs within the seven day allowance. Full amount of rental will be charged for cancellations within 24 hours of reservation.
3. **Gas tank is full on pick up, Bring back full** or we will fill the Rental(s) and lessee will pay us the current price per gallon at other Island Park gas stations plus a **\$10.00 Service Fee** per rental.
4. Normal rental hours are **8:30 a.m. to 5:30 p.m.**
5. **\$55.00 per hour late fee charged per machine beginning at 5:30 pm** minimum 1 hour charge no exceptions don't ask!
6. Retrieval of wrecked or damaged rentals will be charged a recovery fee. **Stuck machines are not our responsibility.**
7. Machines that have been **submerged underwater or in an avalanche will be purchased** by lessee at full retail price. No exceptions. Teton Action Rental will not attempt any recovery of the rental(s).
8. **There is NO REFUND for early returns, WEATHER OR OTHERWISE**

\_\_\_\_\_ I AGREE THAT RENTALS WILL BE RETURNED TO TETON ACTION RENTAL BY NO LATER THAN **5:30 PM** ON THE LAST DAY OF THE RENTAL TERM OR I WILL PAY A **\$55.00 PER HOUR** LATE FEE PER RENTAL.

\_\_\_\_\_ I AM AWARE THAT HIGH MOUNTAIN RENTALS ARE **ONLY LICENSED IN IDAHO**, RENTALS ARE **NOT** ALLOWED IN THE **MT. JEFFERSON** AREA

\_\_\_\_\_ I AGREE TO WEAR A HELMET AND FOLLOW ALL LOCAL LAWS AND REGULATIONS REGARDING THE OPERATION OF SNOWMOBILES. I WILL BE RESPONSIBLE FOR ANY AND ALL FINES THAT I MAY INCURR

\_\_\_\_\_ I AGREE THAT SNOWMOBILES ARE DESIGNED FOR SINGLE RIDERS (**NO PASSENGERS**) DOUBLE RIDER MACHINES MAY CARRY A **MAXIMUM OF TWO PEOPLE.** I AGREE TO PAY A **\$200.00** FINE FOR VIOLATING THIS POLICY AND WILL VOID THE RENTAL TERM IMMEDIATELY. **NO EXCEPTIONS!**

\_\_\_\_\_ I AGREE THAT I WILL BE RESPONSIBLE FOR ANY AND ALL DAMAGE CAUSED BY ABUSE, NEGLIGENCE, OR WILLFULL NEGLIGENCE OR TOWING OF ANY VEHICLE OR DEVICE AND THESE ACTIONS WILL VOID ANY COLLISION INSURANCE. MACHINES RIDDEN IN THE MT. JEFFERSON AREA ARE THE SOLE RESPONSIBILITY OF THE LESSEE INCLUDING MECHANICAL FAILURE. MACHINES THAT HAVE BEEN SUBMERGED OR INVOLVED IN AN AVALANCHE WILL VOID ANY COLLISION INSURANCE AND WILL BE PURCHASED BY THE LESSEE. NO ATTEMPT AT RECOVERY WILL BE MADE BY TETON ACTION RENTAL.

\_\_\_\_\_ I AGREE THAT ALL DAMAGED PARTS ARE REPLACED WITH NEW PARTS AND ANY REPAIR IS MADE AT THE DECISION OF HIGH MOUNTAIN ADVENTURES, there is **no replacement or refund** of wrecked machines.

**I AM** PURCHASING THE COLLISION PROTECTION PLAN FOR THE RENTAL(S) COVERED UNDER THIS CONTRACT. THE RATE IS \$25.00 **\*\*POLARIS PRO CHASSIS MACHINES ARE \$50\*\*** PER DAY PER MACHINE. THE PAYMENT IS **NON REFUNDABLE.** MY RESPONSIBILITY FOR PHYSICAL DAMAGE TO THE RENTAL(S) WILL BE LIMITED TO **\$1200.00** LIABILITY PER ACCIDENT,PER MACHINE.

The undersigned hereby agrees to indemnify, defend and hold harmless the Lessor, and the officers, directors, members, owners, employees, agents, and insurers of Lessor from (i) any claim by the Lessee's family, passengers or any other person whom the Lessee may allow to ride on or operate the leased Rental(s), (ii) any claim of bodily injury by any other party not riding the Rental(s) who suffer injury as a result of the operation of the Rental(s) by Lessee or any other party operating the Rental(s) and (iii) any claim of property damage suffered by any other person resulting from the operation of the Rental(s).
4. The terms hereof shall be binding upon Lessee, and the successors, assigns, personal representatives and heirs of the Lessee. This release shall be binding to the fullest extent possible with respect to the claim of any minor who is the child of the Lessee or for whom Lessee is the guardian of that person.
